Dear Ms. Dauberman:

The Office of Geology and Hydrogeology completed the initial evaluation for a Federal Consistency Determination and assigned the project the number CZ-2024-0825-021. This application is considered complete, and the evaluation period began on August 21, 2023. Notwithstanding, the following information must be provided before September 15, 2023:

1- The proposed project is located within an A Zone and Culebrinas River Floodway according to the Base Flood Elevation Maps (Advisory Maps) of April 13, 2018. Provide the required analysis and information to evidence that the proposed federal activity is consistent with the Special Flood Hazard Areas Regulation (Planning Regulation Number 13) and applicable rules related to floodplain management.

- 2- Provide information on the measures to be applied to avoid and minimize the damage that storms and hurricanes may cause on the proposed tanks and infrastructure, considering the location of the proposed facilities within the Culebrinas river floodway.
- 3- Complete the required information in the models provided as enclosure for the public notice and coordinate to disclose it according to established federal and state procedures. We are available to help in the edition of the Spanish version.
